#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 3. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

- 1. The bidders should submit copies of valid trade license and GST registration and PAN card.
- 2. The Annual Turnover duly certified by a Chartered Accountant for the last 2 (two) years is to be submitte d.
- 3. The AMC will be comprehensive and preventive.
- 4. The Tenderer should have local establishment/support office/service centre in Guwahati and registered in Assam.
- 5. The party should allot one qualified service engineer on a daily basis during the entire office hours to lo ok after all systems at Assam Administrative Staff College covered under AMC.
- 6. The party should ensure that the service engineer(s) visits AASC every day without fail and inspect all th e log books of the systems covered under AMC individually, irrespective of any complaints reported by AA SC.
- 7. The service engineer should record in the log book of each system indicating action taken and system up time with signature of authorised officer of AASC.
- 8. The Party should rectify problems related to hardware, software and operating systems.
- 9. The party should submit the list of at least 2 reputed Clients/Organization of State/Central Govt./PSU/Aut onomous Bodies with whom the bidder has entered into the AMC of Computers and peripherals during last 2 years with the bid, along with copies of satisfactory performance certificate in this field and contract agr eements. (Minimum 2 clients report)
- 10. The party should submit details of service engineers along with their contact details (Mobile and email) and complete address at Guwahati-22.

- 11. The rate quoted must be inclusive of all items including the cost of the service engineer/technician. Fur ther, the quoted price must be inclusive of all taxes.
- 12. If the equipment proposed in AMC is non-functional for more than 24 hours then a pro-rata penalty per day will be deducted, minimum of which will be 3(three) times the amount for every day or part of the day on pro-rata basis. In case any equipment is out of order or non-functional for more than 7 (seven) days the n AASC has the right to get the faulty equipment repaired by some other agency at the RISK AND COST OF THE CONTRACTOR and EMD amount will be forfeited.

#### 4. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

### Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्तें</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in

Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
